Appendix 4A: Property Impacts

Salt Lake County parcel data were used to determine potential property impacts by alternative. The county parcel data do not have complete owner and property address information for the project area. Where the owner and address are missing, the row in the table is highlighted in green, and the expected owner is populated from the Landownership dataset that is maintained by the Utah State Institutional Trust Land Administration (SITLA).

The parcel data, as they are maintained by the County, do not align well with the actual locations on the ground, especially within Little Cottonwood Canyon. The parcel data were spatially manipulated by UDOT to better match road and fence lines visible in aerial photographs, with special consideration given to the property boundaries for historic homes. Due to the data manipulation, the property impact tables should be viewed as an approximation only.

Strip takes on National Forest System land would be under the authority of 23 USC Section 317, or UDOT would obtain an easement or other special-use authorization from the USDA Forest Service. See Chapter 3, Land Use for acres of National Forest System land required for each action alternative.
